The gas analyser module in your Alfa Laval PureSOx system is required for accurate SO_x and CO₂ measurements and therefore compliance.

Why choose refurbished?

Opting for a refurbished gas analyser module is a smart, cost-effective, and sustainable choice. It reduces operational costs without compromising performance. By reusing quality components, we minimize waste and resource use—supporting Alfa Laval’s sustainability goals while helping you maintain compliance and reliability.

Exchange Service (Hot Swap)

Alfa Laval offers an exchange service for gas analyser modules, enabling quick replacement without interrupting system operation. A refurbished unit is shipped to you and can be installed onboard by the crew or an Alfa Laval service engineer. See pricelist for Heat and Gas Systems Service Engineer.

The used module must then be returned to Alfa Laval.

The refurbished module will be shipped within 1 week of receipt of order with a warranty of 1 year. Below is an overview of pricing options:

Option	Description	Price
1.	Module exchange - returned within 1 month	€18.000,00
2.	Module exchange - returned within 3 months	€20.000,00
3.	Module exchange - returned within 6 months	€23.000,00
4.	New module – no exchange	€46.000,00

Monthly late return fee - €1.000,00

Return without Pelican Case - €1.500,00

Pricing is based on returning the damaged module within an agreed upon period and does not include shipping or RMA costs.

Exchange Programme: Gas analyser module via Service Agreements

Alfa Laval will proactively coordinate shipment of serviced gas analyser modules and schedule Alfa Laval Service Engineers to carry out exchange and installation on a biennial basis. This option is available via our service agreements. Benefit from fixed pricing and extended warranty for the duration of the PureSOx Service Agreement.
